As a result, there is great diversity in the veteran population with a variety of presenting problems, age range, and gender.
Description of clinical & training experiences available for students:	Students will focus on providing comprehensive intake and psychodiagnostics evaluations, treatment planning, and very brief recovery-oriented group or individual therapy. Given the diversity of presenting problems, this clinic provides a great opportunity for students to hone their differential diagnosis skills, conduct assessments that result in integrated reports, engage veterans in a collaborative treatment planning process and educate veterans and motivate them to receive evidence-based and recovery-oriented treatments. Presenting problems can include PTSD, mood disorders, anxiety disorders, personality disorders, and comorbidities. Students will have the opportunity to create a unique training plan to focus on specific presentations of interest. Brief interventions would likely include motivational interviewing, CBT, and ACT.

The Recovery Model is a foundation for the CORE program, which assumes all people regardless of mental health diagnosis can live full, meaningful lives. CORE provides comprehensive needs assessments to all Veterans, which include understanding their cultural identities, spiritual needs, and assistive technology needs. In addition, each case is supervised with consideration to all aspects of the Veteran's, trainee's, and supervisor's identify factors and the interactions of those are considered in understanding, interpreting, and providing treatment recommendations. Trainees will be invited to partake in CORE's Cultural Diversity Club, which meets several times through the year, as well as hosts various events and journal clubs focused on diversity topics. Finally, in our weekly Team meetings, we have a specific section for any issues related to diversity, equity, and inclusion to be discussed.

Additionally, there are possibilities to be involved in a rotating cognitive health education series for Veterans and their families as well as other group interventions for Veterans aimed to optimize brain health.

Students in this setting will receive training on standardized neuropsychological assessment procedures and
will have the opportunity to conduct all aspects involved in both brief and comprehensive neuropsychological
evaluations. In all cases this includes chart review, clinical interview and neurobehavioral status exam, test
administration and scoring, interpretation and report writing, and feedback with the Veteran and their family.
PCMHI Neuropsychology (with Dr. Morgan; on-site Mon/Wed/Fri): Older adults whose cognitive concerns have
been identified by their primary care provider or PCMHI mental health provider are referred for brief
neuropsychological evaluation with Dr. Morgan. Referrals for these evaluations include veterans presenting
with new onset or unclear cognitive concerns who would benefit from a brief assessment to triage their
cognitive status and needs, and those with advanced neurocognitive decline (i.e., likely in the dementia range)
These assessments are based on quasi-flexible brief batteries that take up to 2.5 hours to administer. These
evaluations will also offer experiences interacting with the PCMHI/PACT team to integrate the results of the
assessments and implement recommendations, and opportunities to evaluate patients being monitored in
PCMHI at 6 to 12-month follow-up intervals. Optional intervention experiences can include an aging wellness
group for older adults and a cognitive health education series.
MH Neuropsychology (with Dr. Eppig; on-site Mon thru Fri): Adults of all ages with cognitive concerns,
representing a wide range of patient populations with neurological, medical and psychiatric conditions and co-
morbidities. This consult-based service mainly receives referrals from Neurology, Primary Care,
Geropsychiatry, and other Mental Health teams, with a particular focus on serving Veterans who receive care

We serve a diverse range of individuals from a variety of backgrounds: White (53%), Hispanic/Latino (18.9%), Bi-racial (12.6%), Black (7.3%), Asian/Pacific Islander (4.7%), Middle Eastern/North African (.8%), American Indian/Alaska Native (.4%), Unknown (2.2%). Children are frequently referred to DEC by their primary care physician or a community-based screening program. DEC has several formal partnerships to serve special populations of children, including those with full-scope Medi-Cal (California's Medicaid product), those active to Child Welfare Services (including specialized evaluations for children undergoing an adoption process), individuals diagnosed with Angelman Syndrome, children and youth with Cochlear Implants, and those who have undergone cancer treatment.
Description of clinical & training experiences available for students:	Observation & Participation in Live Developmental Evaluations: Under close supervision, demonstrates clinical competency in conducting comprehensive developmental and psychological evaluations for individuals (infants through age six) with a range of developmental, mental health, and medical conditions including but not limited to Autism Spectrum Disorder, Attention-Deficit/Hyperactivity Disorder, anxiety, depression, learning disorders, oppositional/defiant behavior, language disorders, intellectual developmental disability, trauma, fetal alcohol spectrum disorders and other prenatal exposures, and genetic syndromes. Under supervision, demonstrates the

ability to select and competently administer a wide range of psychological tests including assessments for cognitive, achievement, language, motor, visual-spatial/visual motor, adaptive skills, mood/anxiety screeners, trauma screeners, social-emotional/social-communication, mental health and suicide screeners, autism, general behavioral, and executive functioning based on the diagnostic questions.

Direct Supervision During Hands-on Scoring of Test Protocols: Under close supervision, demonstrates clinical competency in both hand- and computer-assisted scoring of a wide range of clinician-administered and self-report and/or parent-completed testing protocols. Show solid understanding of psychometric properties of tests; be able to discuss reliability and validity of various measures; and be able to discuss various types of scoring, how they are related on a psychometric conversion table, and what they mean in specific diagnostic considerations.

Direct Observation & Participation in Writing Patients' Developmental Evaluation Reports: Under close supervision, develops competency in writing comprehensive evaluation reports integrating the referral source and diagnostic question, relevant child and family background, developmental history, presenting concerns, interpretation of testing results, diagnostic summary and related DSM-5 and/or ICD-10 codes, and specific interventions and referrals. Demonstrate ability to compose shorter progress notes to document diagnostic interview and feedback sessions with parents. Demonstrate the ability to use approved templates and Smart Phrases in the electronic health record (EPIC) to document all aspects of patient care.

Direct Observation & Participation of Parental Feedback: With support from supervisor, demonstrate the ability to provide feedback to caregivers regarding test results, diagnosis, and treatment recommendations and referrals. Demonstrate ability to discuss with caregivers all aspects of the evaluation process, meaning of test scores, diagnostic considerations, and treatment planning in a knowledgeable, professional, compassionate, and culturally sensitive manner, allowing for questions from caregivers and time for them to process feelings during and after the feedback session.

Students will also have exposure to didactic trainings and other group learning opportunities provided to our postdoctoral fellows through our APPIC-affiliated fellowship program. Trainings will include exposure to topics such as infant assessment, infant mental health, neurodiversity, speech & language therapy, occupational therapy, physical therapy, feeding team, cochlear implant, hematology and oncology, the Rady Children's KidSTART program, multi-disciplinary assessment of autism spectrum disorders, and others.

Prior to independent administration of a standardized measure, interns must demonstrate competency in the administration, scoring, and interpretation of the measure. Competency tests are tailored to each individual measure and are completed by the primary supervisor or a delegate with expertise in the specific tool. These competency tests are administered upon completion of training on each measure, typically starting in the 2nd-3rd month of training for some measures.

We provide clinical work from a relationship standpoint and utilize modalities such as PCIT, Child-Parent Psychotherapy, Floortime, Child Centered Play Therapy, Video Interaction Guidance, etc when working with parents and children.
